2009 MoArk Mission Board Report

We are excited with our Mission Churches and the progress they have made through the last few years. Thanks to your continued support, we will endeavor with progress to go as Jesus commanded into all the world with the good news of the Gospel. Working together we can do great things. When doing a budget, please, set aside one Sunday a year to take a special offering for MoArk Missions. We will come and give a report on mission work to your church if you would like.

Praise the Lord, the Cross Bridge Church in Bryant, AR has completed a lot of their work and is doing fine. We felt that the MoArk Mission Board needed to give them one more year of support of \$200.00 a month. Also, we will be supporting the AR Home Missions with \$200.00 a month to help other missions that we may not be aware of and may not have the means to do so. We will continue to help Holcomb General Baptist/The Open Door Church with another \$5,000.00 grant which will be paid each quarter in the amount of \$1,250.00 on the condition that (1) they give a report of their progress each quarter, and (2) that the Church continue to hold regular Worship Services, and operate as a Church. The Church did well financially last year, but with the loss of their Pastor, Denver Jackson, they have had some hurdles to overcome. The tithes and offerings for last year was \$66,520.84. This year income may be down.

At the 2010 MoArk Mission Board meeting, Dr. Stephen Gray gave a written report along with Kevin True. A quote from Dr. Gray as it concerns MoArk, "I believe you have made a wise investment in the life of The Open Door Church, and I recommend that you continue assistance, if at all possible. I believe the Church has great potential. I could easily see this Church becoming a regional Church of 400 to 500." Praise the Lord, help us continue this support of the Mission Churches.

MoArk Mission Statement

- 1) In the area of funding it was decided that our efforts should be focused in the following areas;
 - a) Make funds available to struggling churches for revitalization efforts
 - b) Make funds available to churches in times of disaster
 - c) Make funds available to smaller churches for needed upgrades in ministry equipment
 - d) Have funds available for church planting efforts
 - e) Fund seminars, conferences, and rallies in our area that have missions as their focus
- 2) In the area of educating it was decided that our efforts would be focused in the following areas;
 - a) Sponsor and conduct an annual MoArk Missions Rally that would rotate it's missions focus from year to year
 - b) Provide verbal reports to individual churches concerning this boards activities and updates on General Baptist Mission work
 - c) Partner with ministry groups to sponsor and conduct rallies in our area that have missions as their focus
- 3) In the area of volunteer management it was decided that our efforts would be focused in the following areas;
 - a) Organize groups to assist churches with disaster relief
 - b) Organize groups to assist churches with building projects
 - c) Organize groups to assist mission churches in building projects
 - d) Organize groups to assist mission churches in outreach projects

We met three (3) times in 2009, January 19, 2009, August 17, 2009 and October 19, 2009 at the Kennett General Baptist Church.

We started the year making final preparations for the March Seminar with Dr. Larry McKain of New Church Specialties to speak, in depth on the subject of "Re-focusing the Local Church." However, due to the ice storm in late January, we had to cancel our original date and moved it to October 10, 2009 @ the Rector General Baptist Church. However, due to other obligations, Larry McKain was unable to be with us in October so Tim Gates who specializes in the "Re-focusing" arm of their ministry, replaced him and did an excellent job for us.

2009 COUNCIL OF ASSOCIATIONS SUMMARY

THE COUNCIL OF ASSOCIATIONS (C/A) MET AT OAKLAND CITY UNIVERSITY IN OAKLAND CITY, INDIANA, ON MONDAY, MAY 4, 2009.

C/A CHAIRMAN TIM COOK CALLED THE MEETING TO ORDER WITH A DEVOTION AND PRAYER.

THE C/A APPROVED THE 2010 BUDGET AND WILL BE RECOMMENDING IT TO THE GENERAL ASSOCIATION IN JULY. THE C/A APPROVED A RECOMMENDATION BY THE BUDGET COMMITTEE THAT RESEARCH BE DONE BY THE LEADERSHIP TEAM FOR THE GENERAL BAPTIST MESSENGER IN REVISED FORM TO BE GIVEN TO ALL GB HOUSEHOLDS FREE OF CHARGE, WHAT POTENTIAL REVENUE WOULD BE FROM ADVERTISING AND WHAT THE START-UP COST WOULD BE AND TO REPORT THIS TO THE C/A AT THE NOVEMBER 2009 MEETING. AT THE NOVEMBER 9, 2009 MEETING, THE C/A APPROVED A TIMELINE TO MOVE TO A DIFFERENT COMMUNICATIONS PIECE AFTER THE PUBLICATION OF THE JULY 2010 ISSUE OF THE MESSENGER.

THE C/A APPROVED THE CLARIFICATION OF THE C/A PROGRESS COMMITTEE AS AN AD HOC COMMITTEE AND REPLACED ONE OF THE MEMBERS. THE MEMBERS ARE DANNY DUNIVAN, STEVE TIPPEN AND OREN ALCORN.

BRO. JEWEL MARTIN, MINISTRY EVALUATION COMMITTEE MEMBER, REPORTED THAT DUE TO A LACK OF ATTENDANCE BY ITS MEMBERS A PROPER EVALUATION COULD NOT BE CONDUCTED. A REVIEW OF THIS COMMITTEE AND THE FOUR-STEP PROCESS WAS CONDUCTED. C/A CHAIRMAN, TIM COOK APPOINTED CHARLENE SMITH, CHAIRPERSON, JACK BOYER, NICKY WINDERS, BILL MCMILLEN AND RUDD KERR TO WRITE A JOB DESCRIPTION FOR THE MINISTRY EVALUATION COMMITTEE.

EXECUTIVE DIRECTOR, RON BLACK, REPORTED UNIFIED GIVING HAS GROWN BY 3.12% LAST YEAR. FOR THE FIRST FOUR MONTHS OF 2009, WE WERE \$11,000 BELOW GOAL, HOWEVER LAST MONTH (APRIL) WE WERE OVER BY \$30,000 FOR THE MONTH.

IN THE FALL C/A MEETING, THIRTY-TWO NEW MEMBERS WERE INTRODUCED TO THIS BODY.

EXECUTIVE DIRECTOR RON BLACK GAVE A REPORT AND BROUGHT THE MISSION AND VISION STATEMENTS TO OUR ATTENTION. MOARK ASSOCIATION RESOLUTIONS

1. Be it resolved that we ask each church to pay out of its treasury \$6.00 per member association dues for its total attendance and that the Clerk send a letter of reminder that the churches have their reports, dues and \$20.00 for meals sent in before the first week in March. In that letter the Association Clerk will advise the various Church Clerks where this money shall be sent. Any church desiring the Association or Presbytery should make that request in writing to the Association Clerk.
2. Be it resolved that the printing of the Association minutes will be at the discretion of the Executive Board regarding number and format, in order to improve efficiency.
3. Be it resolved that we pay the Associational Clerk/Treasurer \$800.00 for his/her services.
4. Be it resolved that we encourage all churches in the Moark Association to contribute 2% of church income to Camp Allen (if at all possible). This is to be sent to Junior Burnett, Rt.#1, Box 45, Greenville, MO 63944.
5. Be it resolved that we encourage each church to pay all or at least one-half of the tuition for each camper attending Camp Allen.
6. Be it resolved that we encourage each church to invite a representative from Oakland City University to come and share their college activities.
7. Be it resolved that we give our host church a standing vote of thanks for their splendid work in entertaining the Association, and that the Moderator name the host church.
8. Be it resolved that we give the officers and all who participate in today's program a standing vote of thanks for their faithful service.
9. Be it resolved that the delegation of each church bring to their church leaders or church business meeting a request to support Moark Home Missions with 2% of church income (if at all possible). Send contributions to Steve Grimes, 306 Shiloh Road, Paragould AR 72450.
10. Be it resolved that our minute books be printed and ready to use by the Fall setting of the Presbytery.
11. Be it resolved that we encourage all churches in the Moark Association to use Stinson Press for all Literature purchases and printing needs, if cost effective.
12. Be it resolved that we recommend that our MoArk churches become involved in a "Mission Blitz" ministry in each church's community.

CONSTITUTION OF MOARK ASSOCIATION

1. This association, when properly organized, shall have a moderator, vice moderator and clerk/treasurer, who shall be chosen by vote of the members present. The duty of the moderator shall be to keep the association in order, state questions fairly, and take the vote; to have liberty of speech as other members provided his seat be filled; to have no vote unless the members be equally divided in which case, he shall have the deciding vote. The duty of the vice moderator shall be to serve as moderator, automatically, if for any reason the moderator is unable to serve. The duty of the clerk/treasurer shall be to keep a fair and accurate record of all proceedings of the association and to take care of all association monies for which he/she is assigned responsibility and to give an annual report. A second vice moderator shall be elected along with the other officers to become vice moderator at the end of the session.
2. This association shall be composed of all ordained persons and such delegates as shall be chosen from the churches to represent them in the association.
3. Each church shall be entitled to three (3) delegates. A quorum shall consist of the delegates representing six (6) or more churches of Moark Association.
4. Letters from the churches sent to the association shall contain the following information: (1) the number of members presently in fellowship, (2) the number received, (3) the number baptized, (4) the number dismissed, (5) and the names of the deceased since the last regular meeting of the association. Other information may be requested by the association.
5. We agree to do all business by vote of the majority of the members present, except in the reception of members, which shall be unanimous. Since the association is made up of churches, the vote of one delegate may not prevent the reception of a church into membership. A majority of the delegates of one church may prevent acceptance of a new member. In case of a negative vote, the association has the right to require that a reason be given. It has the power to determine the validity of that stated reason. The association may override the negative vote if it determines that an injustice is about to be done.
6. This association shall mother a Presbytery consisting of ordained persons of the member churches and we suggest it meet twice a year.
7. We shall receive no church into fellowship with us who has been excluded from any association until the church has made an honest effort to satisfy the offended body.
8. In a situation where a difference arises between two members in a church and the church acts upon it and settles it, further action by the association is prohibited. However, in the event that any party be aggrieved, that party shall have the right to ask permission of the church to bring the matter to the association for settlement.
9. Any member in good standing shall have the right to act as moderator of the association, when elected by the body.
10. Any minister coming from another association and accepting the pastorate of General Baptist church or churches that belong to this association shall at the first regular session of the Presbytery thereafter have his credentials endorsed by said Presbytery, except in case of loss or destruction, in which case the Presbytery may extend time for recovery of credentials or the securing of a reissue from the ordaining Presbytery or some other Presbytery to which the applicant has subsequently belonged. In case of neglect or persistent refusal to comply with the provision, he will be considered out of order and his work rejected.
11. Any church desiring the ordination of a minister must make application to the Presbytery in writing with recommendation of the same.
12. Any church desiring the ordination of a deacon shall make formal request to the Presbytery for its approval. If the Presbytery approves, he may be ordained at that sitting.
13. Each church that represents in the association shall annually pay per member the amount of dues set by this association.
14. This constitution may be altered by a majority vote of three-fourths of the member composing this body. Any member church that becomes dissatisfied with any part of this constitution or with the Statements of Faith shall be entitled to a letter of dismissal.
15. This association will meet annually on Saturday before the fourth Sunday in March at 9:00 a.m. The exception being when Easter falls on the fourth Sunday in March. In this case the Association will meet on the Saturday before the third Sunday in March. (This provision may be changed by a resolution at any sitting of Moark Association.)
16. The Executive Board of the Moark Association of General Baptists shall operate in lieu of the Association when it is not in session to transact business on behalf of the Association. The Association shall have the right to vote on the dissolution of all or substantially all of the assets of the Association and the acquisition of real property and related indebtedness.
17. This body shall be guided by the General Baptist Doctrine and Usage and Worker's Handbook where no rules are found within the framework of this constitution.
